



**Re-Tender Notice for Selection of Contractors/Firms for the Supply and Installation of DC Standalone Solar Home Systems in Central & Southern Districts of KPK  
(Single Stage Two Envelope Procedure)**

1. Pakhtunkhwa Energy Development Organization (PEDO), Government of KPK is looking for contractors/firms for supply and installation of 2900 DC Standalone Solar Home Systems in Khyber Pakhtunkhwa for the following ADP project.

The project will cover the central (Peshawar, Swabi, Charsadda, Mardan and Nowshera) and southern (Kohat, Hangu, Karak, Bannu, Lakki Marwat, D.I. Khan and Tank) districts of KP.

2. Interested contractors/firms should provide the following information along with their application.
- Details of similar nature of completed and in hand Solar based projects for Government Departments, NGOs, Donors and UN Agencies during the last five (5) years. Satisfactory Performance Certificates for the completed projects must be provided.
  - PEC registration for the year 2016-17 with at least C3 category along with specialized code EE11. Duly signed CVs of Engineers registered by the firm with PEC to be provided. Duly signed CVs of other professional staff working with the firm to be provided.
  - Registration with Securities Exchange Commission of Pakistan (SECP) under companies act (under section 32 of the companies ordinance, 1984 (XLVII) of 1984). (Where applicable).
  - Last two years Income Tax and Sales Tax returns showing annual turnovers in the field of Solar Business.
  - Last two years audited balance sheets, duly audited and attested by a recognized Chartered Accountant firm.
  - The contractors/firms should provide authorized dealership certificates for all the equipments. The Solar equipments must have internationally recognized certifications.
  - Testing facility for pre and post inspection of Solar Panels, Inverters, and Batteries etc should be made available as per ISO Standards.
  - Website addresses of manufacturer/supplier. The record of each component offered should be available online for verification.
  - The bids submitted by the firms shall be evaluated on the criteria given in the bidding documents.
  - Original CDR of 2% of bid price to be attached with financial bid. Bid and CDR amount shouldn't be indicated in the technical bid, otherwise the bid will be rejected.
  - In technical bid an affidavit to be attached stating that CDR of the requisite amount is enclosed in the financial bid.
3. Those foreign firms not registered/licensed by Pakistan Engineering Council (PEC) will be considered for hiring only if those have entered into joint venture (JV) partnership with Pakistani firm (Registered/Licensed by PEC) in category relevant to value of work (mentioned above). In such case, duly executed agreement between the JV partners must be submitted by the foreign firm which should be legally binding both partners jointly and severally, with share of Pakistani firm in joint venture (JV) not less than 33% (Thirty three percent).
4. Interested contractors/firms can download Bidding Documents from the website of PEDO ([www.pedo.pk](http://www.pedo.pk)), upon written request and submission of Demand Draft of Rs. 1000/- (non-refundable) in favor of CEO PEDO.
5. The Technical and Financial bids should reach to the address given below on 25<sup>th</sup> March 2016 in sealed envelopes at 12:00 hrs. The Technical bid will be opened on same date at 03:00pm.
