- Applications for Pre-Qualification shall be submitted through online e-tendering system by getting registered on etender.pedo.pk and hard copies in sealed envelope shall be delivered through registered mail / courier to Room # 219, PEDO Head office, Plot # 38, Sector B-2, Phase-V, Hayatabad Peshawar not later than 17th May, 2022 at 1400 hrs, which will be opened on the same day in presence of the bidders or their representatives who choose to be present at 1430 hrs in committee Room of PEDO. Loose binding / Ring type binding of the proposals shall not be entertained.
- 4. The envelope shall clearly be marked as "Application for Pre-Qualification for the Construction of 10.56 MW Chapare Charkhil HPP".
- No application received after the prescribed time and date in the Pre-Qualification documents or in 5. accordance with subsequent corrigendum, shall be entertained.
