



Notice for Inviting Technical and Financial Proposals

1. Pakhtunkhwa Energy Development Organization (PEDO), Government of Khyber Pakhtunkhwa intends to invite technical and financial proposals on the basis of Single Stage-Two Envelopes (SSTE) bidding process. Interested firms/contractors should be registered with Pakistan Engineering Council in min-category C-4 with Specialization Codes : CE-10, EE-03, EE-04, EE-05, & EE-11(Solar) and having valid registration for the year 2019-20 can apply for the project **"INSTALLATION OF 13 NO's OF SOLAR MINI GRIDS IN MERGED AREAS OF KHYBER PAKHTUNKHWA"**

The Bid will be evaluated on the criteria given in the bidding documents.
4. Incomplete/conditional/telegraphic applications shall not be entertained.
5. Firm must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA).

Single Technical and financial bid for each package sealed in separate envelopes should be submitted to the address given below on or before **22nd October 2019** at **14:30** hours ,which shall be opened on the same day at **15:00** Hrs in the presence of the bidders or their representative opted to attend. Bidders while applying for the Bid must clearly mention name of package and district name on the proposals otherwise client may consider the bid non-responsive.
7. Financial bid for each package must be accompanied by a Bid Security equal to **2%** of the **Bid Cost** in shape of Call Deposit or Pay Order in the name of **"GM (Hydel) PEDO"**.
