


**INVITATION FOR BID FOR "SITE SPECIFIC DESIGN, SUPPLY, INSTALLATION, TESTING & COMMISSIONING OF SEMI-AUTOMATIC PLC CONTROLLED HYDRAULIC TRASH RACK CLEANING MACHINES (TRCM's)"

The Pakhtunkhwa Energy Development Organization (PEDO) (the "Employer") has received funds from the Government of Khyber Pakhtunkhwa through Provincial ADP/HDF which are allocated towards the implementation of the Project "Modification in 81 MW Malakand-III Hydel Power Plant for Restoring its Annual Design Energy Target of 550 GWH". It is intended that part of the funds will be applied to eligible payments under the Contract "Site Specific Design, Supply, Installation, Testing and Commissioning of Semi-Automatic PLC Controlled Hydraulic Trash Rack Cleaning Machines (TRCM's)" on Single Stage Two Envelopes procedure. Bidding is open to all eligible bidders.

1. The Employer invites sealed bids (Technical and Financial) from eligible Firms. Local Bidders shall have a valid license from Pakistan Engineering Council (PEC) in category "C-1". A foreign bidder is entitled to bid only in Joint Venture with a Pakistani Constructor in accordance with the relevant provisions of the bidding documents.
2. The bidder must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and Federal Board of Revenue (FBR).
3. The bidder or at-least one member of the JV must have valid QMS certificates of ISO 9001, ISO 14001 and ISO 18001.
4. Bidders may obtain further information from, inspect at and acquire the Bidding Documents from the office of the Employer addressed below, during working hours or can download from PEDO website via <https://pedokp.gov.pk/Main/tenders>, upon submission of a written application along with a non-refundable fee of PKR 10,000/- only in the form of Deposit at Call from a scheduled Bank of Pakistan in favour of CEO, PEDO.
5. A Pre-bid meeting will be held at the Office addressed as below on **October 2, 2024 at 1100 hours**.
6. All bids must be accompanied by a Bid Security @ 2% of the Price Bid in PKR or equivalent amount in a freely convertible currency in the form of Deposit at Call or a Bank Guarantee on bid security form, issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter-guaranteed by a Scheduled Bank in Pakistan, in favour of the CEO PEDO, valid for a period of twenty-eight (28) days beyond the bid validity date.
7. The Bid must be delivered to the address given below at or before 1400 hours, on **October 17, 2024**. Bids will be opened on the same day, in the presence of bidder's representatives who choose to attend at the Main Committee Room PEDO House, Address: 38/B-2, PEDO House, Phase-5 Hayatabad, Peshawar at 1430 Hrs.
8. The bidders must upload their Technical and Financial proposals in PDF format at <https://etender.pedo.pk/>, in addition to the hard copy/submission. If the website is inaccessible, the bidders must submit a PDF copy of their proposal, including a password-protected financial proposal, in a USB, at the time of bid submission.
