Pakhtunkhwa Energy Development Organization (PEDO) intends to invite bids on Single Stage Two Envelope Procedure on "above / below / at par" basis on Engineer's estimate as per KPPRA rules for the project **Solarization of Judicial Academy and Peshawar High Court Bench Peshawar ADP 2022-23 S# 981/220924**. The scope of work include Procurement, Supply, Transportation, Installation of Solar Street Light including civil works and all ancillary works that shall enable the Commissioning, Testing, and Handing/Taking Over of the Project. The following terms and conditions shall apply.

1. The bidder must have a valid Pakistan Engineering Council registration in the category C5 or above with a mandatory EE11 (Solar).
2. The bidder must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and Federal Board of Revenue (FBR).
3. The bidder must have project specific authorization from manufacturer of PV modules, inverters and batteries.
4. A complete set of Bidding Documents can be purchased and downloaded from etender.pedo.pk by an interested bidder on submission of a written application addressed to PD (Solar) upon payment of a non-refundable fee of Rs. 1000/- and Bidders can also obtain further information from the Office of the Project Director (Solar).
5. A Pre Bid Conference will be held on 24th June, 2024 1100 Hrs at Office of the Project Director (Solar), at House # 21 B-II Abdara Road University Town Peshawar, All Interested bidders may attend.
6. Bidders may obtain further information from, inspect and acquire the Bidding Documents from the Office of the Project Director (Solar) addressed given below.
7. The bidder shall, along with bidding documents, submit 2% bid security of engineer estimate in shape of CDR/Bank Guarantee in the name of the "CEO, PEDO, Peshawar" as per KPPRA rules.
8. The bidders quoting their bids more than 10% below and upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security.
9. The bidders quoting bid more than 20% below shall submit with their bid with 2% bid security and an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineer's estimated along with detailed rate analysis.
10. The last date for submission of bids is July 15, 2024 at 1500 Hr. Bids will be opened on the same day, in the presence of bidders' representatives who choose to attend at Project Director (Solar) Office Address: 21 B-II, Abdara Road, University Town, Peshawar at 1530 hours and also to upload the soft copy on etender.pedo.pk.
