INVITATION FOR BIDS CIVIL WORKS

Sealed Bids are invited by the undersigned from eligible firms/bidders in accordance with KPPRA procurement rules 2014 on single stage single envelope for Civil Works "CONSTRUCTION OF ONE NUMBER LEVY ROOM WITH WASHROOM AT SWITCHYARD". The bidder should be registered with FBR (Income Tax) appear on Active Tax Payer List, KPRA, Pakistan Engineering Council (PEC) for the year 2020-21 in the relevant category, enlisted with Communication & Works Department.

The deadline for submission of Bids on the prescribed format is 16-03-2021 (1030 hrs). The Bids will be opened on the same date at 1130 hrs.

Tender Form, BOQ, complete set of Bid documents and instructions to bidders can be obtained up to one day prior to the opening date from office of the undersigned during working hours. Bid must be accompanied by 2% CDR on Engineer Estimate in the name of the undersigned. Estimated Cost of the bid is **Rs. 1.00 Million**. Bid submitted after the specified submission time will not be considered.

Terms & Conditions:

- 1. Bid/proposal should accompany the following:
 - a. Enlistment certificate of C&W Department (Photo Copy)
 - b. National Identity Card (Photo Copy)
 - c. Pakistan Engineering Council (PEC) registration copy for the year 2020-21 (Photo Copy)
 - d. Proof of being Active Tax Payer
 - e. Documents showing general and relevant experience record.
 - f. Registration of KPRA (Photo Copy)
- 2. Financial Bid should include priced BOQ & Bid Security.
- 3. Incomplete, conditional & bid received after closing time shall not be entertained. Bid shall be signed by authorized persons.
- 4. Bidding shall be done on "Above/Below" system on BOQ/Engineer's estimate, based on the MRS application. Only two digits after the decimal point shall be considered for evaluation purpose.
- 5. Any Bidder who provides incorrect information shall stand disqualified and will be debarred.
- 6. Time allowed for completion of the work will be specified in the LOA.
- 7. Successful Bidder shall sign the agreement with the department within Seven (07) days after acceptance of bid
- 8. Call Deposit of scheduled Banks shall be acceptable.
- 9. If the evaluated bid costs of two or more than two bidders are equal then the successful bidder will be declared through draw.
- 10. The employer has the authority to reject any bid or all the bids assigning valid reason.
- 11. Bid Security of 1st, 2nd and 3rd lowest bidders will be retained by the employer till approval of bid. All Government Taxes will be applicable on Government Contractors as per Govt: Policy.
