TECHNICAL AND FINANCIAL PROPOSALS FOR HIRING OF CONSULTANCY SERVICES FOR THE PROJECT
“SOLARIZATION OF 2000 MASAJID IN MERGED AREA”

Government of Khyber Pakhtunkhwa intends to Solarize 2000 Masajid in Merged Area of Khyber Pakhtunkhwa including Districts of Khyber, Mohmand, Bajaur, Kurram, Orakzai, North Waziristan, South Waziristan and Ex Frontier Regions under the Project **“SOLARIZATION OF 2000 MASAJID IN MERGED AREA”**. Technical and Financial bids are invited from Engineering Consultancy Firms duly licensed by PEC with relevant codes 1210 & 1235. Interested bidders must meet the following minimum terms and conditions:

1. Consultancy firm either independent or JV (lead and partner/partners) must have valid PEC registration along with relevant Codes that are 1210 & 1235. Copy of the valid PEC registration shall be attached as proof.
2. In case of foreign firms entering into JV, form 4C issued by PEC is mandatory.
3. In case of firms entering into Joint Venture, submit JV agreement as per PEC Bye-Laws.
4. Firm must be on active tax payer list (ATPL) of FBR. Proof of active taxpayer status on closing date shall be attached.
5. Registration with KPRA (Khyber Pakhtunkhwa Revenue Authority). Proof of active taxpayer status on closing date shall be attached.
6. Either single or JV firm (lead and partner) must have one number (value => 25 million) of Government sector Consultancy solar building project (design, procurement of contractors, supervision during installation, on site testing of solar equipment's & DLP) completed or in-hand (Off-Grid Hybrid Project) during last 05 years in Khyber Pakhtunkhwa.
7. The Firm/JV should not be black listed from any Government or Autonomous Body (Provide affidavit on original stamp paper that firm is not blacklisted).
8. Interested firms are requested to obtain Request for Proposals (RFPs) on submission of written request and payment of Rs. 2000/- in the shape of demand draft in favor of CEO PEDO from the office of the undersigned during working hours from the next day of advertisement.
9. The Firm/JV shall submit a comprehensive Technical Proposal (Original + 02 copies) and Financial Proposal (Original) in separated sealed envelopes, for services required under the Terms of References (ToRs).
10. The interested firms must apply to this tender by getting registered on etender.pedo.pk and apply online as well as by sending the sealed hardcopies of their bids to the committee room of PEDO house, Plot # 38, Sector B/2, Phase-5, Hayatabad Peshawar on or before at 14:00 HRS on April 11, 2022 and the technical proposals shall be opened on the same day at 14:30 HRS in the presence of bidders in the Committee Room of PEDO.
11. Incomplete/Conditional/Irrelevant experience/Ambiguous application shall not be considered.
