Bidders shall submit their bids to Office of the Resident Engineer Daral Khwar HPC on or before deadline for submission of bids on 14/05/2024 and will be opened on the same date in Committee Room of Daral Khwar HPC as per schedule mentioned against each lot in the presence of the bidder's authorized representative. Bids submitted after the specified submission time will not be considered.
4. The bids must be accompanied by a bid security @ 2% of the Engineer's Estimate in Pak Rupees in the shape of CDR in favor of "Resident Engineer O&M Daral Khwar HPC".
