1. The **Pakhtunkhwa Energy Development Organization (PEDO)** has been entrusted by the **Government of Khyber Pakhtunkhwa** and received funds from the Asian Development Bank (ADB) for the **Construction of Mini/Micro Hydropower Plants Under Access to Clean Energy Program (MMHPPs), Khyber Pakhtunkhwa** to eligible payments under the contract(s) for which this Invitation for Pre-qualification is issued.
2. The **Pakhtunkhwa Energy Development Organization (PEDO)** hereinafter, the Employer intends to pre-qualify Joint Ventures (Constructors & NGOs) for the works pertinent to **Group-B** under the below mentioned project.

**Project description:**

The project “ **Construction of Mini/Micro Hydropower Plants Under Access to Clean Energy Program (MMHPPs), Khyber Pakhtunkhwa**” will be an EPC contract for Joint Ventures (Constructors & NGOs) for the Site Identification/Verification of preliminary identified sites, Feasibility study, Design, Obtaining environmental Approval/NOC from Khyber Pakhtunkhwa Environmental Protection Agency (EPA), Procurement/Supply, Construction, Mobilization of village/community organizations, Testing & Commissioning and optional operation of the plants under the project.

The Bidders will be allowed to bid for any number of LOTs under this Group-B. However a Bidder can be awarded maximum 2 number of LOTs in Streams Lots either in the current bidding process or any past bidding process of the same Project. Whereas this condition doesnot apply for Canals Lots.

3. It is expected that Invitation to Bid will be issued by February 2022.
4. Pre-qualification under Group-B is open to Constructors, in Joint Ventures with NGOs, who are registered with PEC atleast in **Category- C2 or above** for the scope of work described in para 2 mentioned hereinabove. Applications may be submitted for pre-qualification for the above works.  
**The PEC registered entity (constructor) must lead the Joint Venture.**
5. Applicants shall download the prequalification documents from PEDO official website <https://www.pedo.pk> on submission of written application to the office of the Employer's representative, at The Project Director MMHPPs' Office, **2-A, Railway Road, University Town, Peshawar**, upon payment of Rs. 1000/- in the form of CDR/Pay-order in favor of **CEO- PEDO** during office hours from 29-12-2021 onwards up to 02 days before the closing date.

7. Minimum/Pre-requisite requirements for pre-qualification will be as given below:-

9. Any application submitted later than the mentioned time and date will be rejected.

10. Applicants will be informed, in due course, of the result of the evaluation of applications. Only the - Joint Ventures (Constructor and NGO) prequalified under this process will be invited to bid under Group-B

### 2.1 Submission of Applications

- 2.1.1 Applications must be submitted online on <http://etender.pedo.pk/> (**Soft Copy in PDF format only**) and shall also send submit **three (03) hard copies** at **Room No 215, PEDO House 38/B-II, Phase V, Hayatabad, Peshawar** till **18-January, 2022 at 2:00 PM**. . The applications must be clearly marked “Application for Pre-qualification for: Construction of Mini/Micro Hydropower Plants in Group-B, Under Access to Clean Energy Program (MMHPPs), Khyber Pakhtunkhwa”.  
The Applications will be opened on the same date at **02:30 pm** in the presense of the representatives of the bidders who chose to attend the meeting.Any application submitted later than the mentioned time and date will be rejected.
- 2.1.2 The name and mailing address of the Applicant shall be clearly marked on left hand on the envelope.
- 2.1.3 The applications shall be prepared in the English language. Information in any other language shall be accomplished by its translation in English. Employer reserves the rights for dis-qualification incase of non-compliance of the above requirement.
- 2.1.4 The applicants must respond to all questions and provide complete information as advised in this document. Any lapses to provide essential information may result in dis-qualification of the applicant.

## 2.2. Qualification Criteria

### 2.2.1 General

Pre-qualification will be based on the criteria given in succeeding paras 2.2.2 to 2.2.6 regarding the Applicant's Experience Record, Personnel Capabilities, Equipment Capabilities and Financial Soundness as demonstrated by the Applicant's responses in the forms (along with the required documents) attached to this letter. The Employer reserves the right to waive minor deviations, if these don't materially affect the capability of an applicant to perform the contract. Sub-Contractor's experience and resources shall not be taken in to account in determining the Applicant's compliance with the qualifying criteria except of the E&M specialist sub-contractor, as specified under 2.2.2-(ii). However, Joint Venture experience & resources shall be considered. The following detailed evaluation criteria would be applied for applications evaluation, once the minimum requirement has been fulfilled as given in invitation for pre-qualification.

## **2.3 Joint Venture (JV)**

2.3.1 Joint Venture must comply with the following requirements:-

- a) Following are minimum qualification requirements:-
  - i) The lead partner shall meet not less than 40 percent of all qualifying criteria given in paras 2.2 and 2.5 heretofore.
  - ii) Each of the PEC registered Partners of the Joint Ventures, shall meet not less than 25 percent of all the qualifying criteria given in paras 2.2. and 2.5 heretofore.
  - iii) JV partner (NGO) shall meet not less than 5% of the qualifying criteria given in para 2.2.2, 2.2.3 & 2.5 heretofore. In case the NGO share in the JV is more than 25%, NGO shall meet not less than 25% of all the qualifying criteria in paras 2.2 and 2.5 heretofore.  
**However, (PEC registered entity in Category-C2 or above must be in a lead role)**
  - iv) The joint venture must collectively satisfy the criteria of paras 2.2, 2.3 and 2.4, for which purpose the relevant figures for each of the partners shall be added together to arrive at the JV's total capacity. Individual members must satisfy each of the requirements of paras 2.5 and 2.6 heretofore.
- b) Any change in a prequalified JV after prequalification, shall be subject to the written approval of the Employer prior to the deadline for submission of bids. Such approval may be denied if:-
  - i) Partner(s) withdraw from a JV and remaining partners do not meet the qualifying requirements;
  - ii) The new partners to a JV are not qualified individually or as another JV; or
  - iii) In the opinion of the Employer, a substantial reduction in competition would result.
  - iv) Bid shall be signed by all members in the JV so as to legally bind all partners, jointly and severally, and the bid shall be submitted with the JV agreement providing the joint and several liability with respect to the contract as per PEC standard format.

2.3.2.1 The prequalification of a JV does not necessarily prequalify any of its partners individually or as a partner in any other JV or association.

## **2.4 Conflict of Interest**

2.4.1 The Applicant (including all members of a JV) must not be associated, nor have been associated in the past, with the consultant or any other entity that has prepared the design, specifications, and other prequalification and bidding documents for the project, or was proposed as Engineer for the contract, over the last five years. Any such association may result in disqualification of the Applicant.

## **2.5 Updating Prequalification Information**

2.5.1 Bidders shall be required to update the financial, personnel and equipment information used for prequalification at the time of submitting their bids, to confirm their continued compliance with the qualification criteria and verification of the information provided at the time of prequalification. A bid shall be rejected if the Applicant's qualification thresholds are no longer met at the time of bidding.

## 2.6 Other Factors

- 2.6.1 Only JVs that have been prequalified under this procedure shall be invited to bid. A qualified JV or a member of a qualified JV may participate only in one bid for any particular contract under Group B . If a firm submits more than one bid with JVs in any particular Lot under the Project ACEP, all of his bids including that bid will be rejected. This rule will not apply in respect of bids which include specialist sub-contractors who are used by more than one bidder. However, any firm as a partner in a Joint venture for any contract under the subject project, cannot be engaged as a specialist sub-contractor.
- 2.6.2 The Employer reserves the right to:-
- a) Amend the scope and value of any contract(s) to be bid, in which event the bidder(s) will only bid among those prequalified bidders who meet the requirements of the contract(s) as amended. However the Employer has to review the disqualified bids who originally do not meet the specified criteria for Pre-qualification.
  - b) Reject or accept any application; and
  - c) Cancel the prequalification process and reject all applications.
- The Employer shall neither be liable for any such actions nor be under any obligation to inform the Applicant of the grounds for rejection, however, may be debriefed if solicited.
- 2.6.3 Applicants will be informed in writing by mail within reasonable time required to complete prequalification process days of the date for submission of applications of the result of their applications and may be debriefed if solicited.

## EVALUATION CRITERIA

Applicants meeting the minimum requirements mentioned in Para 2.2 besides other factors shall be considered for pre-qualification. No compromise shall be made on minimum requirements of 60% score in each category.
