The Project Management Organization PMO for implementation of Khyber Pakhtunkhwa Hydropower & Renewable Energy Development Program (KHRE) under the Pakhtunkhwa Energy Development Organization (PEDO) (referred as the "PMO" or the Purchaser) has received financing from the World Bank toward the cost of the Khyber Pakhtunkhwa Hydropower & Renewable Energy Development, and intends to apply part of the proceeds toward payments under the contract for Procurement of IT Equipment including Supply, Installation, Configuration & Commissioning. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
2. The PMO now invites sealed Bids from eligible Bidders for Procurement of IT Equipment including Supply, Installation, Configuration & Commissioning.
3. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" November 2020 (Fourth Edition) ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from the undersigned and inspect the bidding document during office hours *[0900 to 1700 hours]* at the address given below.
5. The bidding document in English may be purchased by interested Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of PKR 1,000/-. The method of payment will be in shape of bank draft from any scheduled bank of Pakistan in favour of "Project Director Purchase of land & PMO". The document will be sent by registered mail/courier service.
6. Bids must be delivered to the address below on or before **22<sup>nd</sup> February, 2022 at 1100 AM**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be

publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **22<sup>nd</sup> February, 2022 at 1130 AM.**

7. All Bids must be accompanied by a Bid Security @ 2% of the Bid Price in the currency of the Bid.
