- 1- The Project Management Organization (PMO) for implementation of Khyber Pakhtunkhwa Hydropower & Renewable Energy Development Program (KHRE) under the Pakhtunkhwa Energy Development Organization (PEDO) (referred as the "PMO") has received financing from World Bank toward the cost of the aforesaid program, and intends to apply part of the proceeds toward payments under the contracts for "Procurement of IT Hardware & Equipment including Supply, Installation, Configuration & Commissioning at PMO KHRE, PEDO House, E&P Dept. - 4- Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" November 2020 (Fourth Edition) ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
- 5- Interested eligible Bidders may obtain further information from the undersigned and inspect the bidding document available at www.pedo.pk.
- 6- The bidding document may be purchased by interested bidders from the office of undersigned from **02-01-2023** on written request and upon payment of non-refundable fee of Rs. 1000/- in the shape of CDR/Pay order in favor of **Project Director Purchase of Land & PMO.**
- 7- Sealed Bids must be delivered in 03 hard copies (One original and Two copies) to the below mentioned office on or before at 2:00 PM on 16-01-2023 and will be publicly opened on the same date at 2:30 PM in the presence of the bidders' designated representative. Late Bids will be rejected.
- 8- Bidders must be registered and on Active Taxpayer list (ATL) of Federal Board of Revenue (FBR) for Income & Sales Tax (NTN/STN).
- 9- All bids must be accompanied by Bid security @ 2% of the bid Price in the Form of Call deposit or a Bank Guarantee issued by the scheduled Bank of Pakistan in favor of 'Project Director Purchase of land & PMO'.
