REQUEST FOR PROPOSALS FOR HIRING OF INDEPENDENT VERIFICATION AGENT/AGENCY FOR THE PROJECT "THE ACCESS TO CLEAN ENERGY PROGRAM IN KHYBER PAKHTUNKHWA"

Government of the Khyber Pakhtunkhwa has vision to provide Mini / Micro hydro-power and solar solution to communities, homes, basic health units and schools to reduce burden on National Grid and to improve the environment conditions of the province. Under the program approximately 1000 micro hydropower projects (MHPs) on streams and canals with approximate capacity range of 20KW to 1500KW, solarization of approximately 8000 Schools and 187 Basic Health Units (BHUs) have to be developed. For which hiring of IVA Consultancy Services is under progress.

Now PEDO intends to hire the services of a National/International Consultants on Lump Sum basis as "**INDEPENDENT VERIFICATION AGENT/AGENCY**" (IVA) to provide independent results verification of the progress and / or completion of the indicators linked to the Program. The IVA will independently verify the results of the indicators from the Monitoring and Evaluation (M&E) and Disbursement Linked Indicators (DLIs) under the ADB results-based lending (RBL) program. Overall, the IVA will prepare a report that shall be submitted to PEDO and later distribution with the ADB and AFD.

In particular, the IVA will validate the PEDO's results of (i) base line data verification; ii) the indicators in the program Design and Monitoring Framework (DMF), and DLIs; (iii) the Program Action Plan; and (iv) compliance with the RBL and program agreements etc.

Other Information's:

1. The Consultant should be registered with concerned professional body from their country of origin.
2. The Consultant will be selected under the Selection Method Quality and Cost Based (QCBS) 80:20 Technical and Financial Weightage respectively and procedures, in accordance with the Khyber Pakhtunkhwa Procurement Regulatory Authority (KPPRA) Rules.
3. It is mandatory for proposals to be made using the Standard Forms of the RFP. Proposals that are not in the prescribed format will be discarded. If any information required in the forms is found missing or written elsewhere, no credit will be given in the relevant section of the evaluation.
4. Firms should submit details of at least experience in **2 projects of similar nature or experience in performance auditing of 2 infrastructure projects in any sector**, completed during the last (10) years as prescribed format in RFP.
5. CVs of key personnel corresponding to the list given in the Data Sheet should provide all relevant details.
6. Consulting Firms must obtain signed copy of RFP at the cost of Rs. 3,000/- (Non-Refundable), in form of CDR in favor of Project Director, MHPs, PEDO, from the office of the undersigned on a written request during the office working hours from **12/02/2018** onwards up to one day before the closing day.
7. Technical and Financial Proposals (sealed separately) one original and three copies must be submitted at the address mentioned below on **19/03/2018** by 1100 Hrs.
8. Technical proposals shall be opened on the closing day at PEDO House in the presence of authorized representatives of firms who may choose to attend.
9. The pre-bid meeting shall be held on **12-03-2018**
