The Pakhtunkhwa Energy Development Organization (PEDO) (the "Employer") has received funds from the Government of Khyber Pakhtunkhwa through Provincial ADP/HDF which are allocated towards the implementation of the Project "6.95 MW Mujahidin Hydropower Project at Barandoo River, District Torghar (MHPP)". It is intended that part of the proceeds of the funds will be applied to eligible payments under the Contract for detailed Engineering design of all the Project components, Procurement, Supply, Construction, Erection/Installation, Testing and Commissioning etc. of the MHPP. The major Works include:

- Civil Works (including but not limited to Weir, Intake, Conduit, Headrace Tunnel, Surge Tank, Penstock's anchor and thrust blocks, Powerhouse and allied structures/facilities, colony and access roads etc.).

- 11 KV double circuit Transmission Lines of accumulative length 43 Km & 400/230 Volt distribution system of accumulative length 60 km, complete in all respect.

The Project is located at a distance of 173 Km from Peshawar and 230 Km from Islamabad on Right Bank of the Indus River in District Torghar, Hazara Division. The Completion period of the Project is 36 months (1095 days). Bidding is open to all eligible Bidders. The following terms and conditions shall apply:

- The Employer invites sealed bids (Technical & Financial bids) from eligible Firms. Local Bidders shall have a valid license from Pakistan Engineering Council (PEC) in category "CA-No Limit". A Foreign Bidder is entitled to bid only in a joint venture with a Pakistani constructor in accordance with the relevant provisions of the bidding documents.
- 2. Bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and Federal Board of Revenue (FBR) in accordance with the relevant provisions of the bidding documents.
- 3. Bidders may obtain further information from, inspect at and acquire the Bidding Documents from the office of the Employer, addressed below during working hours or can download from PEDO website via https://pedokp.gov.pk/Main/tenders, upon submission of a written application along with a non- refundable fee of PKR 20,000/- only in the form of Deposit at Call from a scheduled Bank of Pakistan in favor of CEO, PEDO.

- 5. All Bids must be accompanied by a Bid Security @ 2% of the Price Bid in PKR or an equivalent amount in a freely convertible currency in the form of Deposit at Call or a Bank Guarantee on bid security form, issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter-guaranteed by a Scheduled Bank in Pakistan, in favour of the CEO PEDO, valid for a period twenty-eight (28) days beyond the bid validity date.
