### **Terms & Conditions:**

1. Eligibility criteria is as follows :
  - a) Enlistment certificate of C&W Department (Photo Copy)
  - b) Renewal of Registration for CFY 2019-20 (Photo Copy)
  - c) National Identity Card (PhotoCopy)
  - d) Pakistan Engineering Council (PEC) registration for the year 2019-20 (Photo Copy)
  - e) Documents showing general capability, financial soundness, general and relevant experience record minimum, personal capabilities, list of own equipment and income tax / NTN certificates.
  - f) Detail of works of similar nature completed in past (05) years or in hand.
  - g) Certificate of Registration with Income Tax Department.
  - h) Current bank statement and certificate from a scheduled Bank with respect to financial soundness of the firm.
  - i) Active tax payer certificate and income tax return of the last two years.
  - j) Affidavit to the effect that Firm has never black listed by the Government.
  - k) Bids should be sealed envelopes must reach the office of the Resident Engineer O&M Malakand-III HPC Dargai on or before the fixed date and time.
2. Financial Bid should include priced BOQ (hand written in figures and words) & Bid Security.
3. Incomplete, conditional & bid received after closing time shall not be entertained. Bid shall be signed by authorized persons.
4. The bidders who quote their bids/rates more the 10% below the Engineers estimate shall also submit an additional security sealed in envelop, in the form of call deposit equal to 8% of the estimated cost.
5. Bidding shall be done on "Above/Below" system on BOQ/Engineer's estimate, based on the MRS application. Only two digits after the decimal point shall be considered for evaluation purpose.
6. Any Bidder who provides incorrect information shall stand disqualified and will be debarred.
7. Time allowed for completion of the work will be specified in the LOA.
8. Call Deposit of scheduled Banks shall be acceptable.
9. If the evaluated bid costs of two or more than two bidders are equal then the successful bidder will be declared through draw.
10. The employer has the authority to reject any bid or all the bids assigning valid reason.
11. Bid Security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders will be retained by the employer till approval of bid. All Government Taxes will be applicable on Government Contractors as per Govt: Policy.
12. If a bidder fails to fill the bidding documents in accordance with the instructions to bidders, his bid will be considered as non-responsive.
