### IMPLEMENTATION OF PHASE-I & PHASE-II SOLARIZATION OF 130,000 HOUSES.

The Pakhtunkhwa Energy Development Organization (PEDO) (the “Employer”) is going to implement the Chief Minister Khyber Pakhtunkhwa initiative for Solarization of 130,000 Houses under a financing agreement (FA) with the Bank of Khyber. Under the proposed Financing Agreement (FA), the Solarization of 130,000 Houses will be implemented in Two Phases. For this purpose, PEDO intends to pre-qualify the interested/eligible bidders for the “Procurement of Supply, storage, installation of the Solar Home Systems (SHS)” as per the terms of the Pre-Qualification Documents.
