**EXPRESSION OF INTEREST FOR SHORTLISTING OF CONSULTING FIRMS REGARDING
CONSULTANCY SERVICES FOR THE PROJECT "THE ACCESS TO CLEAN ENERGY PROGRAM IN
KHYBER PAKHTUNKHWA"**

Government of the Khyber Pakhtunkhwa has vision to provide Mini / Micro hydro-power solution to communities, homes, basic health units and schools to reduce burden on National Grid and to improve the environment conditions of the province. Under the program approximately 672 micro hydropower projects (MHPs) on streams and canals with capacity range of 20KW to 1500KW are to be developed.

For this purpose, PEDO intends to hire National/International/JV Consultants for, but not limited to, preparation of bidding documents, evaluation of bids, assistance in pre-bid conference, award of contract and post-bid inspection, quality assurance and installation supervision of Contractor for the said project. More details of the project are available on PEDO website. The Consulting firm will be hired for the said assignment as per provisions of Khyber Pakhtunkhwa Procurement Regulatory Authority (KPPRA) Rules 2014.

1. Pre-requisite for Shortlisting

The interested firms should meet the following minimum requirements & must attach the documentary proof with their applications for prequalification/shortlisting for the said project otherwise the firm(s) will not be considered.

1	Certificate of registration with concerned professional body from their country of origin.	
2	Copy of Registration with Income Tax Department / NTN / Sales Tax Number, for local firm(s).	
3	Consultancy services provided for at least two (02) hydropower projects completed during last ten (10) years.	
a)	Cost of services, as lead firm, not less than Rs.350 Million for individual project	
b)	Completion Certificates from the employer clearly stating the services rendered	
4	A certificate / affidavit that the firm(s) is not blacklisted by any public sector organization and has not been or involved in litigation during the last ten (10) years with any public sector organization in & outside Pakistan.	

Note: Item 1, 2 & 4 are mandatory for each consultant/firm, applying individually or in JV

2. Other Terms & Conditions

- The above pro-forma, duly filled, must be attached on top.
- All the documents must be provided in the above stated sequence.
- Incomplete/Conditional/Ambiguous applications shall not be considered.
- PEDO reserves the right to cancel the process at any stage as per KPPRA rules.
- Application should reach on or before 4th April, 2017 on the address mentioned below.
- Request for Proposal (RFP) shall only be issued to the shortlisted consultants.
- 70% of key personnel (local + international) will be from lead firm in case of JV.
