3	Package-3 (Hazara Region)	Abbottabad, Haripur, Mansehra, Batagram, Kohistan & Torghar.
4	Package-4 (South Region)	Bannu, Lakki Marwat, Kohat, Hangu, Karak, Tank & DI Khan.

- 2. Interested firms must submit separate proposals for each package.
- 3. Interested firms / companies may form a joint venture (JV) with local or foreign consultants for proposals as per PEC guidelines. The proposal submitted by joint venture (JV) must be accompanied with documents in support of formation of venture. Such documents must set forth the extent of responsibilities. The participation of each member of joint venture (JV), its duration and person authorized to present and obligate it and include other relevant information.
- 4. The proposal should consist of : a). Background and experience in solar power projects including in hand projects and work done during the last five (5) years. b). Detail & number of proposed professionals to be assigned to carry out services, CVs duly signed by engineers along with proof of degree and registration with Pakistan Engineering Council (PEC). c). CVs of the engineers registered by the firm with PEC to be provided. d). CVs of the other professional staff working with the firm to be provided. e). Financial soundness and financial position (Bank statements and Tax returns) of firm for the last three (03) years. f). The firm/Company must be registered with Pakistan Engineering Council (PEC) having relevant code (1210) for Renewable Energy Sources and Systems. g). Project office/Sub-office in Peshawar. h). NTN required.

- 6. Interested firms are requested to obtain Request for Proposal (RFP) on payment of Rs. 2000 in the shape of Demand Draft in favour of CEO PEDO from the office of undersigned during working hours from the next day of advertisement.

The consultant/joint venture should submit a comprehensive Technical Proposal in English (original+one copy) and Financial Proposal (original+one copy) in separated sealed envelopes, for services required under the Terms of References, should reach on the following address on or before 9th October, 2017 at 11:00 HRS which shall be opened in the presence of the bidders on the same day at 11:30 HRS.
