Notice for Pre-Qualification of Contractors/firms

1. Pakhtunkhwa Energy Development Organization (PEDO), Government of KPK invites applications for Pre-Qualification of contractors/firms for the project "Solar Electrification of 4000 Masajid in Khyber Pakhtunkhwa". The contractors/firms should be registered with Pakistan Engineering Council (PEC) in at least C-3 category and should have adequate financial soundness, similar work experience, personnel capabilities and relevant equipment etc. The project will be implemented in the following packages:

- 2. Interested firms must submit separate proposal for each package. A firm/Contractor can submit proposals for a maximum of two (02) packages.
- 3. Interested contractors/firms should provide the following information along with their application.
 - Details of similar nature of completed and in hand Solar based projects for Government
 Departments, NGOs, Donors and UN Agencies during the last five (5) years. Satisfactory
 Performance Certificates for the completed projects must be provided.
 - b. PEC registration for the year 2017-18 in at least C-3 category along with specialized code EE11. Duly signed CVs of Engineers registered by the firm with PEC to be provided. Duly signed CVs of other professional staff working with the firm to be provided.
 - c. Registration with Securities Exchange Commission of Pakistan (SECP) under companies act (under section 32 of the companies ordinance, 1984 (XLVII) of 1984).
 - d. Last two years Income Tax and Sales Tax returns showing annual turnovers in the field of Solar Business.
 - e. Last three years audited balance sheets, duly audited and attested by a recognized Chartered Accountant firm.
 - f. The contractors/firms should provide authorized dealership certificates for all the equipment. The Solar equipment must have internationally recognized certifications.
 - g. Testing facility for pre and post inspection of Solar Panels, Inverters, and Batteries etc should be made available as per International Standards.
 - h. The firm must have valid ISO 9001 certificate for Quality Management System.
 - Website addresses of manufacturer/supplier. The record of each component offered should be available online for verification.
 - j. The profiles/documents submitted by the firms shall be evaluated on the following criteria.

3	Personnel Capabilities	15
4	Equipment Capabilities	20

- 4. Those foreign firms not registered/licensed by Pakistan Engineering Council (PEC) will be considered for pre-qualification only if those have entered into joint venture (JV) partnership with Pakistani firm (Registered/Licensed by PEC) in category relevant to value of work (mentioned above). In such case, duly executed agreement between the JV partners must be submitted by the foreign firm which should be legally binding both partners jointly and severally, with share of Pakistani firm in joint venture (JV) not less than 33% (Thirty three percent).
- 5. Interested firms are requested to download Pre-Qualification Documents (PQD) on request from the website of PEDO (www.pedo.pk).
- 6. Incomplete/conditional/telegraphic applications shall not be entertained.
- 7. The required documents/information should be sent to the address given below on or before 11th October 2017 at 11:00 HRS in sealed envelopes which shall be opened in the presence of the bidders on the same day at 11:30 HRS. The proposals should clearly mention the package for which the firm is applying
