Recommendation of the Procurement Committee:

- 1- As per RFP data sheet clause 5.1, Note 2, 60% marks are mandatory for passing in category I, II & III.
- 2- The firm obtaining 70% and above marks are qualified and recommended for opening of their financial proposals. It is therefore recommended that Procurement Committee may open the Financial Proposals of the Firms (Sr No. 1,2,5) who have scored 70% and above marks.
- 3- The bidder at Sr # 3 has failed the mandatory passing criteria of minimum 60% in category-I & III and overall minimum 70% marks therefore the committee evaluated the proposal as " Not Qualified"
- 4- The bidder at Sr # 4 has failed the mandatory passing criteria of minimum 60% in category-I and overall minimum 70% marks therefore the committee evaluated the proposal as " Not Qualified"
- 5- The bidder at Sr # 6 has failed the mandatory passing criteria of minimum 60% in category-I and overall minimum 70% marks therefore the committee evaluated the proposal as " Not Qualified"
- 3- The Procurement Committee unanimously recommends to the Management Committee to approve the Technical Evaluation Report for hiring of consultancy services for construction of Mujahidin Hydropower Project and may allow the Procurement Committee to open the financial proposals of qualified firms (ACE JV, PES JV & NDC JV).
