5. OPENING OF BIDS

Pursuant to the results of evaluation carried out in Annex-C, only A & S Trading meet the minimum qualification and other bidding requirements and is declared as 'Substantially Responsive'.

Whereas, the rest of the bidders failed to meet the minimum qualification and other bidding requirements as discussed in Annex-C and are considered as 'Non-responsive'. Accordingly, the Bids submitted by these Bidders are rejected.
