MINUTES OF THE PROCUREMENT COMMITTEE MEETING HELD ON 17th JANUARY 2023

Venue / Time: PEDO House, Hayatabad – January 17, 2023 (1530 hrs)

Meeting Agenda: Opening of Technical Proposals for the Pre-Qualification of Contractors for the Project

- (i) Solarization of Mosque/Masajid/Madrassa/Janazgah & Eid-Gah at Uc's Balkot, Shingal Dra, Bartoni, Harnail, Shatal, Judba, Manjakot, Palosa, Kand Akazai, Mera Mada Khel, Shadag Of District Torghar

Meeting for the Opening of Proposals was held under the chairmanship of the Project Director Solar-PIU being authorized by Chief Engineer Procurement and Contract, in the main committee room of PEDO. The meeting started with recitation of the Holy Quran, list of the participants is attached (Annex-I).

The Chair welcomed the participants of the meeting and invited the Deputy Director (P&C) Solar-PIU to brief the forum on the background of the process for the subject project mentioned in the agenda item of the meeting.

1. Deputy Director (P&C) briefed the forum that notice of invitation for pre-qualification of contractors was published in daily newspapers on 20th December 2022 with pre-bid conference on 29th December 2022 and bid submission on or before 17th January 2023.
2. Director (Planning) PEDO inquired the contractor's representatives whether they have any authorization letter for submission of the pre-qualification proposals on behalf of their companies. Some responded that they weren't aware of such requirement while some responded that it's already covered in letter of application and is part of the proposal. He explained to all the participants that it's a basic requirement and is also the only way to assess the genuine participation of any company/firm. He further advised to ensure separate authority letters apart from being provided in the sealed copies of the proposal while attending any bid/proposal submission. Project Director (Solar) also emphasized that authority letter will be checked as mandatory requirement for future bids/tenders.
3. Deputy Director (P&C) further elaborated that following eleven (11) Contracting firms have participated for the pre-qualification process and have submitted their proposals both in hard form and soft form on PEDO E-Tender till closing time as per terms & conditions of the NIT: -
