**NOTIFICATION**

It is hereby notified for the information of all concerned that land owners of Muza Ashoran Kalam have agreed to sell their land as per their share to the Energy & Power Department Govt of Khyber Pakhtunkhwa through PEDO measuring 52 Kanal 08.80 Marla which is notified under section IV of LAA 1894 vide this office No. 4052/176/Acq/DC(S), dated 04/02/2021 at a price of Rs.8.5 Million per Kanal through mutual understanding.

To facilitate the land owners/interested persons, the PEDO Management agreed for Rs 1.5 Million per Kanal as objects damaging/compensation from the Resettlement Action Plan of the Project.

Since the land measurement plan and individual ownership record has been prepared by the Field Revenue Staff on the identification of PEDO staff, thus this can be viewed at the offices of the undersigned, Chief Engineer/Head PMO KHRE PEDO Peshawar, AC Bahrain and Tehsildar Kalam, on any working day during office hours.

Any objection, in this regard may be filed to the undersigned within fifteen (15) days of the publication of this notification failing which the record shall be considered as authentic and compensations will be paid accordingly.
