The 3rd meeting of the Management Committee of PEDO in the capacity of Executive Committee was held on June 21, 2021 under the Chairmanship of CEO PEDO in the Committee Room of PEDO House Peshawar in light of the decision taken during the 7th meeting of the PEDO Policy Board held on May 07, 2021 and subsequent notification dated June 03, 2021 of PEDO Issued to this effect. APPROVAL OF THE MANAGEMENT COMMITTEE RECOMMENDATION ON THE FINANCIAL BIDS EVALUATION (TECH+FIN) OF THE TECHNICALLY QUALFIED FIRMS/BIDDERS FOR HIRING OF INDEPENDENT VERIFICATION AGENT/AGENCY (IVA) FOR THE PROJECT "ACCESS TO CLEAN ENERGY PROGRAM,-SOLARISATION OF 8000 SCHOOLS & FACILTIES IN KPK"

- PD Solarization of Schools and BHUs informed the forum that in pursuance to the approval of technical evaluation by PEDO Management Committee in its meeting held on June 03, 2021, the Procurement Committee meeting was convened on June 10, 2021 for opening of financial bids of the following two technically qualified firms:
 - M/S NESPAK (pvt) Ltd **(i)**
 - M/S Eastern Engineering (pvt) Ltd (ii)
- The Project monitoring unit, after carrying out the evaluation of the financial bids, presented the evaluation before the Procurement Committee on June 14, 2021 for recommendations. As the method of the Selection is LCBS (Least Cost Based Selection), the Procurement Committee recommended M/s Eastern Engineering Consultant being the technically qualified and lowest evaluated bidder for award of Contract on their bid cost of Rs. 6,434,000/-.
- The detail of overall cost comparison of the awarded contracts against the approved cost as per PC-1 was explained to the forum by the Project Director.
- The forum was requested to approve the final evaluation (Tech + Financial) duly recommended by the Procurement Committee and further allow the project monitoring unit to

award the Contract to the lowest evaluated qualified bidder/Firm (M/s Eastern Engineering Consultants) on their Bid Cost of Rs. 6,434,000/-.

DECISIONS:_

- 7. After detailed discussion, the forum decided as under:
 - (i) The final evaluation (Tech + Financial) as recommended by the Procurement Committee was approved and allowed the project monitoring unit to award the Contract to the lowest evaluated qualified bidder/Firm (M/s Eastern Engineering Consultants) on their Bid Cost of Rs. 6,434,000/-.
 - (ii) A detailed revised technical sanction shall be issued based on the cost breakup of each bided work portion;
 - (iii) PD Solarization of Schools shall quickly initiate the process of revision of the PC-I.
 - (iv) The financial bid shall be notified properly and placed on the website as per KPPRA rules;
