Hiring of Security firm for Providing Security to PEDO Main Office Building.

SUMMARY OF THE BIDDING PROCESS

INTRODUCTION

Sealed Bids were invited from eligible firms/bidders under KPPRA Procurement Rules 2014 on Single Stage Single Envelope for Providing Security To PEDO Main Head Office Hayatabad Phase-V, Peshawar, Khyber Pakhtunkhwa.

SUBMISSION & OPENING OF BIDS

A total of five (5) bidders/firms purchased the bidding documents before the deadline for submission of Bids, i.e., January 04, 2024, 1400 Hrs, and the same submitted their proposal. Bids were opened on the same day at 1430 Hrs..

SUMMARY OF RESULTS:

The overall summary of results are tabulated below in ascending order, based on the evaluated bid price.

RECOMMENDATION OF THE PROCUREMENT COMMITTEE, PEDO:

The Procurement Committee unanimously recommended the following options for consideration of the Management Committee, PEDO, to approve the award of the contract under IB 19 and 20 of the bidding document, the Contract for the "**Hiring of Security Firm for Providing Security to PEDO Main Office Building.**"

Option No. 1:

The Bidder at Sr.No.4 **M/s Ghazi Security Guards (Pvt.) Ltd. Peshawar** has an evaluated bid price of **PKR. 11,220,000/Year** (Rupees Eleven Million Two Hundred Twenty Thousand Only). The Bidder proposal fully complies with the requirements of the bidding documents, and based on compliance, the bidder proposal stands **Substantially RESPONSIVE BID**.

Option No. 2:

The Bidder at Sr.No.1 **M/s Sarhad Security Services (Pvt) Ltd. Peshawar Cantt** has the lowest evaluated bid price of **PKR. 8,994,600/Year**, (Pak Rupees Eight Million, Nine Hundred Ninety-four Thousand and Six Hundred rupees only). The bidder's proposal does not meet the full compliance of the bidding document, i.e, Not uploading his bid on the online e-tendering system of PEDO; however, the procurement committee considered this as a minor non-conformity according to IB 16.6 of the bidding document, subject to clearance by MC PEDO.

RECOMMENDATION FOR AWARD OF THE CONTRACT:

The competent authority PEDO approved the award of the contract to the lowest evaluated financial bidder **M/s Sarhad Security Services (Pvt) Ltd. Peshawar Cantt** at an evaluated bid price of **PKR. 8,994,600/Year** (Pak Rupees Eight Million, Nine Hundred Ninety-four Thousand and Six Hundred rupees only) with the direction that the wages/remuneration of the employees shall not be less than those notified by the labor department from time to time.
