- (ii) The JV at Sr No. 2 " (JV) M/s Electra Consultants (Lead member), M/s Technical, Engineering and Management Consultants, (TEAM) (JV member) & M/s Civ TECH Associates Consultant (JV member) " has failed the mandatory passing criteria of minimum 60% marks in category-I; therefore, the procurement committee evaluated the proposal as "Not Qualified".
- (iii) The JV at Sr No. 5" (JV) INTEGRATION Environment & Energy GmbH (Lead Firm), M/s Abid Zeshan Management Engineering Consultant (AZMEC) (JV Member), Integration Energy Pvt Ltd (IEPL) (Associate Member) & Frontier Engineering Consultants (FEC) (Associate Member) has failed the mandatory passing criteria of minimum 60% marks in category-I; therefore, the procurement committee evaluated the proposal as "Not Qualified".
