Pre-Bid Meeting dated June 13, 2022

Ranolia Hydropower Project Complex-Construction of Protection Embankment Upstream of PowerHouse at Ranolia Hydropower Project, District Lower Kohistan-

The Experience other than the specific name of works will be considered as General work experience	
5.	<p>Bidders referenced clause 11.2 of the subject tender's Instruction to Bidders, which states that "the bidder should have executed at least three (3) specific projects of similar size and nature, including construction of protection / Embankment / flood protection works, worth Rs.35 million during the last 5 years.</p> <p>The bidder should have at least ten (10) years' general experience in construction of civil works with minimum of 5 projects at least of Rs.15 million and above"</p> <p>The bidder requested for considering the worth Rs. 35 Million combinely for three specific projects as mentioned in the above clauses of bidding documents.</p> <p>The bidder also requested for considering the experience with name other than specific projects which have already the components of Embankments and Protection works.</p>	<p>The clause IB 11.2 of the bidding document is changed with the following: "The Bidder should have executed at least three (3) specific projects of similar size and nature, including construction of Protection / Embankment / flood protection works, each having worth Rs.35 million during the last 7 years."</p> <p>The instruction as amended above in the bidding documents will be followed.</p> <p>The Experience other than the specific name of works will be considered as General work experience</p>
