**INVITATION FOR BID FOR “HIRING OF SERVICES OF AUDIT FIRM FOR EXTERNAL
AUDIT OF FINANCIAL YEAR 2023-24”**

Pakhtunkhwa Energy Development Organization (PEDO) (hereinafter called “The Client”) invites sealed bids from well-reputed firms to provide consulting services for external audit for the financial year 2023-24, under a Single Stage Two Envelope bidding procedure on QCBS at 80:20, in accordance with KPPRA procurement rules 2014, extendable on yearly basis upon satisfactory performance.

General terms and conditions:

1. The bidder shall be listed as Category “A” on the panel of auditors maintained by the State Bank of Pakistan (www.sbp.org.pk).
2. The bidder shall be registered with the Federal Board of Revenue (FBR), Pakistan & Khyber Pakhtunkhwa Revenue Authority (KPRA) and shall have preferably “Active” status on the last date for the bid submission. In case of registered firms with “In-Active” status the firm must register itself prior to issuance of LOA if their bid became successful failure to do so shall lead to rejection of their bid.
3. The applicants shall download the complete set of Request for Proposal (RFP), available on the PEDO official website <https://www.pedo.pk/> on written application to the office of the undersigned upon payment of Rs. 3,000/- in the form of CDR/pay order in the name of CEO, PEDO during office hours prior to the closing date.
4. Incomplete / Conditional/ Ambiguous applications shall not be considered.
5. PEDO reserves the right to reject any one or all the bids as per rule 47 of the KPPRA 2014.
6. The pre-proposal meeting will be held on **08th May 2024 at 1500 Hrs** in the Main Committee Room of PEDO, located at Plot No. 38/B-2, PEDO House Phase-5, Hayatabad, Peshawar.
7. The bidder must submit hard copies of their proposal (Technical & Financial) in the office of the undersigned on **20th May, 2024 at 1500 Hrs** or the latest date of bid submission at the address given below.
8. Prospective bidders must registered themselves on the PEDO website **etender.pedo.pk** and upload the PDF format of their Technical and Financial Proposals.
