



**INVITATION FOR BID**  
**“REHABILITATION & RESTORATION OF RANOLIA HYDROPOWER**  
**PROJECT CIVIL WORKS LOT-II, DISTRICT KOHISTAN LOWER”**



**SINGLE STAGE TWO ENVELOPE (SSTE) PROCEDURE**

The Pakhtunkhwa Energy Development Organization (PEDO) (the “Employer”) has secured a loan from Asian Development Bank (ADB) under the Loan No. 3476-Pak, towards the cost of Rehabilitation & Restoration of Ranolia Hydropower Project, District Kohistan Lower. It is intended that part of the proceeds of the loan will be applied to eligible payments under the Contract for the Civil Works Lot-II, the detail of which is defined in the scope of work in Bidding Document. Bidding is open to all eligible Bidders. The following terms and conditions shall apply:

1. The Employer invites sealed bids (**Technical & Financial Bids**) from eligible Firms. Local Bidders shall have a valid license from Pakistan Engineering Council (PEC) in category “**C1 and above**”.
2. Bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and Federal Board of Revenue (FBR) in accordance with the relevant provisions of the bidding documents.
3. Bidders may obtain further information from, inspect at and acquire the Bidding Documents from the office of the Employer, addressed below during working hours or can download from E-PAK Acquisition and Disposal Systems (EPADS), upon submission of a written application along with a **non-refundable** fee of **PKR 10,000/-** only in the form of Bank Draft in favor of GM Hydel Securities, PEDO.
4. A Pre-bid meeting will be held in PEDO House, Sector 38/B-2, Phase-V, Hayatabad, Peshawar on September 16, 2025 at 11:00 hours.
5. All Bids must be accompanied by a **Bid Security** of **PKR. 36 Million** (Pakistani Rupees Thirty Six Million only) or an equivalent amount in a freely convertible currency in the form of **Bank Draft** or a **Bank Guarantee** on bid security form, issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter-guaranteed by a Scheduled Bank in Pakistan, in favour of the CEO PEDO, valid for a period twenty-eight (28) days beyond the bid validity date
6. Additional bid security shall be submitted in accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) **Notification No. S.R.O. (14)/Vol: 1-24/2021-22** dated **May 10, 2022**, including provisions regarding additional security and abnormally low bids as per Regulation No. XIV of 2022.
7. Bidding shall be done on “Above / Below / at Par system” on BOQ / Engineer’s Estimate based on MRS 2024 (1st Bi-Annual). The “Above / Below / at Par system” is also applicable to the Non-Schedule (NS) items included in the BOQ / Engineer’s Estimate. Technical and Material Specifications of Khyber Pakhtunkhwa MRS-2024 shall be applicable to the Project.
8. All bidders are directed to submit their bids through EPAD (E-Pakistan Acquisition and Disposal System).
9. The technical and financial bids must also be submitted in hard form to the office of undersign before closing time as mentioned in NIT.
10. Bidders failing to submit their bids through both systems (Refer to Sr. No. 8 & 9 of Advertisement) shall be declared non-responsive and their bids shall not be considered for evaluation.
11. The Bid must be delivered to the address given below at or before 14:00 hours, on September 25, 2025. Bids will be opened on the same day at **14:30 hours**, in the presence of bidder’s representatives who choose to attend.
12. The Employer may reject all bids or any proposal at any time prior to acceptance of a bid or proposals. The Employer shall upon request communicate to any bidder, who submitted a bid or proposal, the grounds for rejection of all bids/proposals as per Section 47(1) of KP-PPRA Rules 2014.
