**E-TENDER NOTICE FOR "PROCUREMENT AND INSTALLATION OF 33 KV
TRANSMISSION LINE ACCESSORIES AND TRANSFORMERS FOR RESHUN TO
KARGIN (FEEDER-III/LOT-II), RESHUN HPC DISTRICT UPPER CHITRAL"**

The Pakhtunkhwa Energy Development Organization (PEDO) (the "Procuring Entity") has received approval from Provincial Government, towards the cost of 4.2 MW Reshun Hydropower Complex, District upper Chitral. It is intended that whole or part of the proceeds of the fund will be applied to eligible payments under the Contract for the Project "PROCUREMENT AND INSTALLATION OF 33 KV TRANSMISSION LINE ACCESSORIES AND TRANSFORMERS FOR RESHUN TO KARGIN (FEEDER-III/LOT-II), RESHUN HPC DISTRICT UPPER CHITRAL" on Single Stage One Envelope procedure. Bidding is open to all eligible Bidders. The following terms and conditions shall apply:

1. The Employer invites sealed bids from eligible bidders. Bidders shall have a valid license from Pakistan Engineering Council (PEC) in category "C6 and above" with mandatory specialized code EE04 & EE05.
2. Bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and Federal Board of Revenue (FBR) in accordance with the relevant provisions of the bidding documents.
3. Bidders may obtain further information from, inspect at and acquire the Bidding Documents from the office of the Employer, addressed below during working hours or can download from E-PAK Acquisition and Disposal Systems (EPADS), upon submission of a written application along with a non-refundable fee of PKR 2,000/- only in the form of Bank Draft in favor of GM Hydel Securities, PEDO.
4. The bidders must submit their bids through the EPADS, on or before Jun 03, 2026, by 1500 Hrs. In addition, sealed hard copy of the bid shall be delivered to the address below not later than the bid submission deadline. Bids not submitted through EPADS, will be declared non-responsive and will not be considered for evaluation. Submission of hard copy is required solely for evaluation purposes. In the event of any discrepancy or ambiguity between the hard copy and the electronic submission, the bid uploaded on EPADS shall prevail.
5. All Bids must be accompanied by a Bid Security amounting to PKR 2% of the Quoted Cost in the form of Bank Draft, issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter-guaranteed by a Scheduled Bank in Pakistan, in favor of the CEO PEDO, valid for a period of twenty-eight (28) days beyond the bid validity date. The bidding documents will not be issued on the last date of bid submission.
6. The Employer may reject all bids or any proposal at any time prior to acceptance of a bid or proposals. The Employer shall upon request communicate to any bidder, who submitted a bid or proposal, the grounds for rejection of all bids/proposals as per Section 47(1) of KP-PPRA Rules 2014.
