

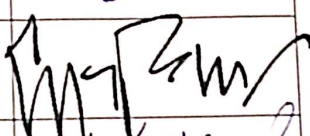
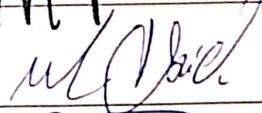
## 12 SUMMARY OF RESULTS
