Pakhtunkhwa Energy Development Organization (PEDO) intends to invite bids from the pre-qualified bidders on Single Stage One Envelope Procedure on "above / below / at par" basis on Engineer's estimate as per KPPRA rules for the project **"SOLARIZATION OF 2000 MASAJID IN MERGED AREA- ADDITIONAL 1050 MASAJID"**. The scope of Works includes Initial Site Survey, Procurement, Supply, Transportation, Installation of Solar system including civil works and all auxiliary works that shall enable the Commissioning, Testing, and Handing/Taking Over of the Project. The following terms and conditions shall apply:

- Bidding is open to the firms pre-qualified for the subject project only notified via Notification No. PD (Solar-PIU) Solarization of Projects/2023-24/PD/7086-91, dated 05-03-2024 issued by the office of Project Director (Solar). The selection of contractors will be based on Single Stage One Envelope (SSOE) procedure in accordance to rule 14, sub-clause 2(a) mentioned in KPPRA procurement rules 2014. - The pre-qualified bidders intending to participate in all packages are required to submit separate sealed bids for each Package. A combined bid for all packages shall not be accepted and will be declared non-responsive.
- The pre-qualified bidders shall have a license from the Pakistan Engineering Council (PEC) in the category C-3 or above with a mandatory specialization codes as mentioned in the bid document.
- The pre- qualified bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and Federal Board of Revenue (FBR) and shall have 'Active' status as of the latest date for bid

5. The pre-qualified bidders may obtain further information, inspect, and acquire the Bidding Documents from the office of the Employer at the address given below during working hours, or download them from e-PADS upon submission of a written application along with a non-refundable fee of PKR 5,000/- per package, in the form of a Bank Draft from a scheduled Bank of Pakistan, in Favor of "CEO, PEDO". Bidders intending to participate in more than one package shall submit a separate fee for each package.
6. A pre-bid meeting for pre-qualified bidders will be held at Main Committee Room, PEDO House, Sector 38/B-2, Phase-V, Hayatabad, Peshawar on **July 16, 2026 at 1100 Hrs.**
7. The bidders must submit their bids through the E-PAK Acquisition and Disposal System (EPADS), on or before **July 28, 2026, by 1400 Hrs.** In addition, sealed hard copies of the bids shall be delivered to the address below not later than the bid submission deadline mentioned above. Bids not submitted through EPADS, will be declared non-responsive and will not be considered for evaluation. Submission of hard copies is required solely for evaluation purposes. In the event of any discrepancy or ambiguity between the hard copy and the electronic submission, the bid uploaded on EPADS shall prevail.
8. The financial proposals of all the participating firms will be opened at Main Committee Room, PEDO House, Sector 38/B-2, Phase-V, Hayatabad, Peshawar, on the same day at **1430 hrs** in presence of the procurement committee and representatives of the concerned firms.
9. All Bids must be accompanied by a Bid Security amounting to PKR 2% of the estimated cost in the form of Bank Draft or a Bank Guarantee on bid security form, issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter-guaranteed by a Scheduled Bank in Pakistan, in favour of the "CEO, PEDO" valid for a period twenty-eight (28) days beyond the bid validity date. Bidders participating in more than one package shall submit separate Bid Securities for each package. Additional bid security shall be submitted in accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated May 10, 2022.
10. The Employer reserve the right to reject any or all bids at any time prior to acceptance of a bid or proposals. The Employer shall upon request communicate to any bidder, who submitted a bid or proposal, the grounds for rejection of all bids/proposals as per rule 47(1) of KPPRA Rules 2014.
